This notice hereby serves as a formal reminder to Chief Financial Officer and AGL Sales Pty Limited with ABN 88 090 538 337 (hereinafter, AGL) of the potential state of dishonour and extends to you the opportunity to correct this matter and honour your obligations. Prior to the initiation of any further action as outlined within this notice, you are granted the opportunity to cure the matter in accordance with the terms set forth herein.

I hereby affirm that the tender for payment of \$536.86 for Reference Number ???? ???? ???? ???? and Statement of Account for Service Address 1 Chess Avenue, Elwood, was duly indorsed and delivered to you via registered post with a letter on 09 April 2025. Registered post reference RPP44 ????? ????? ????? See enclosed copies.

It is further affirmed that the indorsement provided for the reference number and service address above has been retained by your office without return or discharge of AGL's associated liabilities. This refusal and/or failure of AGL to discharge its liabilities constitutes a breach of various statutory enactments and contractual principles, including, but not limited to, the Bills of Exchange Act 1909 (Cth) and relevant principles under the Australian Consumer Law. Such breaches place AGL in a state of dishonour.
