Looking to better understand the legal chains that bind you into voluntary servitude under a de facto, foreign corporation masquerading as the de jure government of Australia? The surname, presumed as property of the Crown, severs the 'sacred' living soul from its estate, reducing the man or woman to a surety for 'secular' corporate obligations.

A scam so beautifully crafted and embedded in education, government oversight, and propaganda, enforced through courts-for-profit with circular jurisdiction press-ganging you and the surname as trustee, where men and women are presumed corporate entities (persons, citizens, individuals) and commercial law, not true common law, governs contracts, obligations, and status. The State and Courts thus operate as foreign, for-profit trust managers, administering estates that rightly belong to the sacred living, and not the secular dead.

Common law is nothing more and nothing less than the people’s power expressed as reason and common sense, protecting the living from harm, loss, and fraud.

By contrast, statutes are legislative enactments. They apply not to the living, but to publicly registered legal entities—corporate franchises of the State. Statutes confer only limited “privileges and benefits” upon these artificial persons, prescribing commercial rules and regulations that operate strictly by consent. They are not law in the true sense, but the colour of law: administrative codes governing State-created entities for the profit and convenience of the State, that is the Crown, that is the Vatican, that is the One World Order.

1. A Lawful Blueprint, showing where the law begins.

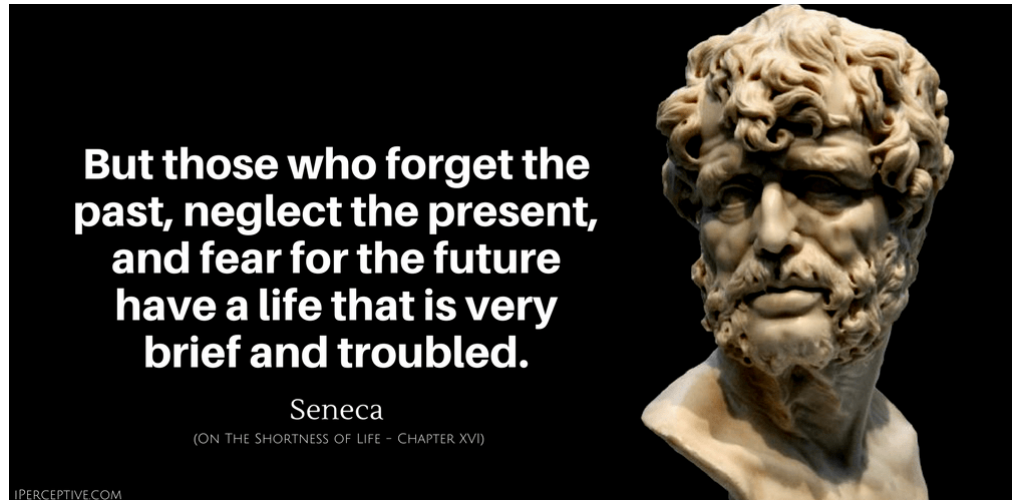
